New Compliance Webinar Addresses AHJ

2020 Prairie Design Awards Cancelled

The Manitoba Association of Archtects (MAA), Saskatchewan Association of Architects (SAA) and the AAA have collectively agreed that this year's Prairie Design Awards should be cancelled, in recognition of:

- the inability to host large gatherings anytime in the foreseeable future, due to the pandemic, which makes a physical awards ceremony impossible; and
- the evolving economic impact on all of the respective member firms, which
 would make it difficult for many, if not all, to assemble submissions for an
 awards program in the midst of these challenges.

The Associations have collectively agreed that, in light of the rotation that has been consistently maintained between the three jurisdictions since the inaugural year, the MAA will host the Prairie Design Awards in 2022.

Updated CALA Documents

The National Standing Committee on the <u>Canadian Architectural Certification</u>

<u>Board</u> recently presented updates to the <u>Conditions for Licensure of Architects in Canada</u> to the Canadian Architectural Licensing Authorities (CALA).

These updates that were approved by CALA and endorsed by the AAA Council, highlight the standards and definitions of competency, forms of comprehension, the roadmap to licensure and the various pathways to licensure and the related components.

Also included is the <u>Canadian Education Standard for Architects</u>, a document that lays out the details and academic requirements for the Canadian educational standard for architects. The AAA encourages members to review these documents.
